Presentation – Lincoln Theatre Foundation: Lincoln Theatre Foundation Director of Operations provided a history of the theatre and shared

upcoming events to celebrate the theatre's 100<sup>th</sup> Birthday.

- B. Approval of Agreement - Washington State Recreation and Conservation Office (WA RCO): Mr. Reinart requested approval of a grant agreement with WA RCO to provide funds for the Carpenter Creek/Hickox Road Fish Passage Improvement project.

**Councilmember Beaton moved to approve an agreement with WA RCO to provide a funding for the Carpenter Creek/Hickox Road Fish Passage Improvement project in the amount of \$3,193,314. Motion seconded by Councilmember Hudson. Motion passed 7-0.**

- C. Approval of Resolution – K9 Program: Chief Christman requested approval of Resolution 1090 authorizing the reinstatement of the K9 program. The program will be funded by General Fund revenue.

Mayor Donovan acknowledged that funds have been moved around to use General Fund revenue to fund the startup costs for the K9 Program. The Resolution establishes a K9 Program to combat the rise of drug related crimes and the increase of drugs being brought into the City. Council approved the reinstatement of the K9 Program during the 2026 budget process and the budget includes K9 funding.

Councilmember Hudson spoke in favor of the K9 Program. She proposed approval of Resolution 1090, with the caveat of adding a process for accepting applications for the remaining opioid settlement funds.

Mayor Donovan, Mr. Volesky and Council discussed the funding of the K9 program, the IOS funding, opioid settlement funds disbursement, and K9 deployment policies.

**Councilmember Tercero moved to approve Resolution 1090 re-establishing the Police Department K9 program. Seconded by Councilmember Beaton. Motion failed 4-3**

**SUBJECT:** RE: ORDINANCE ADOPTING THE WASHINGTON STATE ANIMAL CRUELTY STATUTE

**RECOMMENDED ACTION:**

Passage of the Proposed Ordinance

**INTRODUCTION/BACKGROUND:**

The City of Mount Vernon has authority to prosecute misdemeanor crimes - crimes punishable up to a maximum of 364 days in jail \$5000 fine or both. This is done through adopting crimes in its municipal code.

Washington State has adopted the gross misdemeanor of Animal Cruelty in the Second Degree pursuant to RCW 16.52.207. In order to grant the City authority to prosecute this crime, state law requires that it be adopted into the City's municipal code. The statute has gone through a number of amendments since its original adoption - including three in the past 10 years.

The proposed ordinance adopts the state law by reference as now or hereafter amended. Any future amendments to the state law would then be automatically adopted by the City without further need of legislative action.

**FINDINGS/CONCLUSIONS:**

That it is in the best interest of the City to adopt Washington State's crime of Animal Cruelty in the second degree.

ORDINANCE NO. 3936

**AN ORDINANCE OF THE CITY OF MOUNT VERNON, WASHINGTON  
RELATING TO ANIMAL CONTROL AMENDING CHAPTER 6.04 OF THE  
MUNICIPAL CODE.**

**WHEREAS**, City Council finds there it is in the best interests of the City to adopt laws prohibiting animal cruelty.

**NOW, THEREFORE, THE CITY COUNCIL OF MOUNT VERNON,  
WASHINGTON, DO ORDAIN AS FOLLOWS:**

**SECTION 1. Amendment.** That Mount Vernon Municipal Code Section 6.04.200 is hereby amended to read as follows:

**6.04.200 Cruelty to animals.**

RCW 16.52.207, Animal Cruelty in the Second Degree is hereby adopted by reference as it now exists or hereafter may be amended.

**SECTION 2. Severability.**

Should any section, paragraph, sentence, word, clause or phrase of this ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this ordinance be pre-empted by state or federal law or regulation, such decision or pre-emption shall not affect the validity of the remaining portions of this ordinance or its application to other persons or circumstances.

**SECTION 3. Effective Date**

This Ordinance shall take effect five days after its publication.
