Council is governed in part by MVMC 2.12

City Councilmembers must complete required Open Public Meetings Act and Public Records Act training within 90 days of appointment.

City Council meetings are on Wednesdays. Committee begins at 6pm. Council meetings begin at 7pm on the 2<sup>nd</sup> and 4<sup>th</sup> Wednesdays of the month. A Council Study Session may be scheduled at 7pm on the 1<sup>st</sup> and 3<sup>rd</sup> Wednesdays of the month.

Councilmembers receive a stipend of \$14,400 a year, paid twice monthly.
